UEM Sunrise 'Smiling Proud - Finding Smiley' Contest

1. Introduction

- 1.1. These terms and conditions ("Terms and Conditions") shall govern the **UEM 'Smiling Proud Finding Smiley'** ("Contest") that is organised by UEM Sunrise Berhad ("Organiser").
- 1.2. The Organiser reserves the right to at any time, change, amend, delete or add to the Terms and Conditions and other rules and regulations including the mechanism of the Contest at its sole discretion.
- 1.3. The Organiser may terminate or suspend the Contest at any time at its absolute discretion in which case, and the Organiser may elect not to award any prize (s). Such termination or suspension will not give rise to any claim by the contestants. The Contest will be held during the Contest Period as defined below.
- 1.4. 2. Contest Period

- 2.2. The Organiser reserves the right to vary, postpone or re-schedule the dates of the Contest or extend the Contest Period at its sole discretion.

3. Eligibility

- 3.1 The Contest is open to: \cdot Malaysian citizens only \cdot Aged 16 and above; and \cdot Followers of UEM Sunrise official Facebook and Instagram ("Contestant").
- 3.2 No purchase of any UEM Sunrise Berhad's product is necessary to participate in this Contest.
- 3.3 Organiser reserves the right to disqualify Contestants and/or revoke the prize (at any stage of the Contest) if in Organiser's sole determination, the entry does not meet the Contest Mechanics (as defined below).

- Step 3. Share the answer on the comment box of the contest post and tag three friends
- Step 4. One participant is allowed to submit only one answer. Multiple answers will disqualify the participant's entry.
- Steps 5. Participants who fulfil the above criteria will be eligible to win a RM100 Grab Gift Voucher via a lucky draw
- 4.2 Winner Selection
